# **BOARD APPROVES SCIENCE STANDARDS**

The State Board of Education voted 6-1 to approve *Nebraska's College and Career Ready Standards for Science*. State law requires updates to standards every seven years. The revised standards create the framework for science education in Nebraska. Input from science and educational experts and public online surveys was used to craft the final draft. Dozens of people also provided feedback through public comment during several board meetings and the board was given letters of support from community colleges, independent and private institutions, the state college system and the university system.

## ACT CUT SCORES SET

The ACT is now the state's standard assessment for all public school juniors. The State Board of Education voted 7-0 to set cut scores with three different levels: the ACT Benchmark, On Track, and Developing. A student scoring in the top two levels would be meeting state expectations for the assessment. The cut scores were developed with input from Nebraska's post-secondary institutions and through a special committee.

## ESSA PLAN HEADED TO WASHINGTON D.C..

Nebraska's plan for the federal Every Student Succeeds Act (ESSA) will soon be sent to the U.S. Department of Education. Commissioner Matthew Blomstedt presented the plan to the State Board of Education for their approval. Members unanimously voted to send the plan to the U.S.D.E. who now have 120 days to review Nebraska's plan and provide feedback before moving forward.

## FRESH FRUIT AND VEGGIES PROGRAM

Nebraska schools will receive almost \$500,000 in federal funds for fresh fruits and vegetables. More than 50 schools will receive money through the Fresh Fruit and Vegetable Grant Award Program (FFVP). The FFVP has been a nationwide program since 2008 and operates in elementary schools in every state.
