

2018 Direct Certification Training

This course will introduce training participants to the new Direct Certification (DC) System which identifies students who automatically qualify for free or reduced price meal benefits.

<u>Attendance Requirements:</u> All School Food Authorities (SFAs) are required to have at least one staff member attend training. The only exceptions are Residential Child Care Institutions, Educational Service Units, milk only schools, and summer camps.

Ideally, training participants are staff member(s) who work directly with the CNP Direct Certification system.

Registration Requirements: Registration is required as space is limited. Registration ends <u>one week</u> (seven days) prior to when the training is offered at each location. Multiple training dates are listed for some locations; however, you only need to register for <u>one</u> training session.

To maximize training resources; I) training dates may be merged together to ensure that each day of training has at least 12 registered participants; 2) SFAs with more than one registered participant may be asked to share the same computer. **Each participant** must bring their own CNP log in to work in the system and complete class survey/assessments.

- Step I: On the left hand side of the screen, under Links, click on Register for Training.
