PURPOSE

To provide information about Nebraska School District responsibilities related to data reporting.

- Who is responsible for reporting data about a student (and possible data necessary to be submitted);
- What district does student performance data become attached to for purposes of accountability and public reporting.

The scenarios and different situations among Nebraska schools are unique and diverse, but the information provided within this publication intends to provide clarity on specific situations.

DEFINITIONS

<u>Attendance</u>: Attendance is the time a student is present on days when school is in session. The Attendance data is derived from the reported absence data and the calendar will be used to calculate average daily attendance.

<u>Courses:</u> Used to collect information regarding courses students in grades prekindergarten through 12 complete during a particular school year.

<u>Discipline</u>: Refer to the **ADVISER Discipline Guidance** document on the ADVISER Resources website for more information.

<u>District/System of Membership:</u> The approved or accredited district/system where the student received the majority of their instruction – includes Public Districts, Nonpublic Systems and Special Purpose Schools.

<u>District of Residence:</u> The Public School District where the student resides. Resident shall mean a person who has his or her residence in a place. It should be noted that the Legislature has specifically provided in Section 79-215 (1) R.R.S. that, except as otherwise provided in § 79-215 R.R.S., a student is a resident of the school district where he or she resides and shall be admitted to any such school district upon request without charge.

Enrollment: A cumulative set of all students enrolled in a district/system at any time during the school year and represents a student's most current information.

Nebraska Department of Education Student ID: An NDE Student ID is required for all students attending or provided services from a Nebraska District/System.

<u>Post School Survey:</u> For all 12th grade Career Education Concentrators identified as a completer with diploma in the previous school year.

Programs:

Career and Technical Education: Collected to support the federal reporting of the Carl D. Perkins Career and Technical Education Act.

Early Childhood Education: A cumulative set of students; include all students served in the specified Early Childhood Education Program at any time during the school year.

Homeless Education: A cumulative set of students; include all students eligible for Homeless Education services at any time during the school year.

Rule 18 Interim-Program School: A cumulative set of students; include all students served by a Rule 18 Interim-Program School at any time during the school year.

Special Education Program: Collects data on students with verified disabilities on an Individualized Education Plan (IEP) or Individualized Family Service Plan (IFSP). This includes point in time count, October 1 each year and the year end, June 30 count

Section 504 Program: An indication that a student is receiving services under Section 504 of the Rehabilitation Act of 1973; include all students receiving services at any time during the school year.

Title I Program: Collects information on a variety of Title I services a student may have received at any time during the school year.

For additional Program information, please see Section 8 in the ADVISER Data Elements document.

School Enrollment: Collects information on student enrollment events, both enrollment and withdrawal, during the school year.

<u>School of Membership</u> - For most students, the School of Membership is the school where the student is enrolled for the majority of their instruction. For students attending a program (e.g. focus, Rule 18, ESU, alternative programs, or career academies), the School of Membership is the school where the student would be enrolled either due to residence in the district or due to assignment.

School Year: June 30 is used as the logical representation of the end of a school year.

APPENDIX B — Exempt School/Home School Process and Coding for Enrollment

Exempt School/Home School Process and Coding for Enrollment

Parent notified the school district they are filing for Exempt/Home School.

School district should check the Exempt Schools – School District Report (found in the NDE Portal within the Data Collections tab) to review the application submitted by the parent.

IF Started/Working:

This status indicates the parents or legal guardians have created an account to file through the Nebraska Exempt School online system, but have not submitted to NDE. The student should remain enrolled and if the student is not attending school, the student should be reported as absent.

IF Submitted/Pending NDE Review:

The student should remain in enrollment until the Exempt Schools – School District Report (found in the NDE Portal within the Data Collections tab) shows the student with a status of Submitted. The student's enrollment code reported is 205 (not enrolled eligible to return), using the <u>date</u> the Exempt Schools – School District Report shows the student as having a "Submitted" filing. The district will <u>not</u> continue to report the student absent.

IF Submitted/Under NDE Review:

NDE is awaiting further information from the parents/legal guardians before the review can be completed. The student's enrollment code reported is 205 (not enrolled eligible to return), using the date the Exempt Schools – School District Report (found in the NDE Portal within the Data Collections tab) shows the student as having a "Submitted" filing. See Exempt Date or Filing is Incomplete below.

Exempt Date:

NDE Exempt School Staff will review and process the filing; once complete, the status of the submission will show an Exempt Date next to the student's date of birth. As of the Exempt Date, the student can be reported as a 201 (transfer out).

Filing was Incomplete. School has been notified:

IF a filing Submitted/Under NDE Review and subsequently the parents/legal guardians have not responded to NDE's requests for information, the resident district Superintendent will be notified of noncompliance (as per 92 NAC 13-005). On the Exempt Schools – School District Report (found in the NDE Portal within the Data Collections tab), the student will show as deactivated with the notation "Filing is incomplete. School has been notified." Add the student back into the district's student information system for follow-up related to truancy as per the district policy. Showing the student with enrollment code 205 (Not Enrolled Eligible to Return).
