The 100 hours of supervised clinical experience required prior to student teaching includes aiding, assisting, and teaching lessons. These experiences occur during courses in child and adolescent development and methods courses including special needs and high ability learners. State requirement is that all candidates must complete a minimum of 14 weeks of student teaching experiences. Candidates in initial certification programs at Creighton University complete a minimum of 16 weeks in student teaching experiences. For the number of adjunct faculty supervising clinical experience, I entered the number of university supervisors who are employed by our University as adjunct professors. We do not employ P-12 mentor teachers; they provide their mentoring services to our candidates as professional service. In the past, previous reporters from our University included P-12 mentor teachers in this number.

The teacher candidates take an instructional technologies course where they learn the basic uses of various technologies that can be used in a classroom setting for instruction and for assessment. They complete lesson plans/units, design assessments, and use a variety of hardware and software programs to create instructional activities and materials in meeting the needs of diverse learners. Our electronic course management system, BlueLine (based in Instructure), enhances the use of technology within courses taught and activities presented by students. A state-of-the-art technology classroom, designated for education students, opened in the fall of 2013. Students also have access to Student Collaboration Labs where technology is available for individual and group work. Near Pod, a web-based teaching tool, is allowing our students to more effectively learn how to engage in one-to-one instruction using their note book computers and a classroom projection screen connected to a computer. At this time, we have concluded that Near Pod is sufficient for teaching our students one-to-one instructional strategies because our students learn the strategies to use in a one-to-one classroom and can apply these strategies across a variety of learning management systems. Beginning in 19/20, our undergraduate students will all complete a course in the assessment of learning. This course will enhance student ability to use technology for the purposes of assessment and research. Graduate students also cover similar content in a graduate level technology course and in a graduate level assessment and research strategies course.

Moreover, the teacher candidates complete a 15-hour pre-student-teaching field experience in a special education or resource room to gain experience in working directly with students with disabilities. An IEP team activity is conducted as part of the coursework. The teacher candidates also receive information in the Diversity course and the Inclusion course in working with both gifted students and students who are English language learners. Creighton University is located in the heart of Omaha near one of the inner city areas. Students in initial certification programs are placed in field experience settings that include schools with high levels of free and reduced lunch students, English language learners, and racially/ethnically diverse populations. Jesuit charisms (values) that emphasize social justice and service are highlighted in content and field experiences as an important aspect of developing dispositions for teachers, in addition to the rigorous expectations of knowledge and pedagogy. We are currently developing a teacher residency model program at the secondary level in order to provide a more effective program that is also affordable for teacher candidates. As we have been developing our new teacher residency program, we have evaluated and enhanced our curriculum. We are adding new curriculum threads in culturally responsive teaching, trauma informed instruction, ESL, and teacher ethics. We are also developing a data base that will allow us to more easily store, access, and analyze data on our teacher candidates and program completers. We anticipate the work on our data base project continuing during 19/20.
