Minutes

The Nebraska State Council on Educational Opportunity for Military Children held its annual meeting on September 9, 2019. Publicized notice of the meeting was given by posting notice on the Department's website on the Internet, which gave the date, time and location of the meeting.

1. CALL TO ORDER AND INTRODUCTIONS

Brian Halstead, Deputy Commissioner of the Nebraska Department of Education and Council Commissioner of the State Council on Educational Opportunity for Military Children, called the meeting to order at 1:30 p.m. The following members were present: Matthew L. Blomstedt, Commissioner of Education; Dr. Jeff Rippe, Superintendent, Bellevue Public Schools; Nicole Barrett, representative for Senator Mike Groene; and Sara Hulac, Military Family Liaison and Legal Counsel. Col. Alan Dayton, Commander, U.S.A.F. 55th Wing Mission Support Group, Offutt Air Force Base, was absent, but Lt. Colonel Andrew Stewart, U.S.A.F., 55th Wing Mission Support Group Deputy Commander, Offutt Air Force Base was present as Col. Dayton's designee.

Brian Halstead announced the placement of the Open Meetings Act.

Dr. Rippe reported that the Bellevue Public Schools has not heard of any issues this past year. The transfer of students from a military family into and out of the Bellevue Public School system is running smoothly thanks in large part to his staff and their dedication to serving the military families.

Lt. Col. Andrew Stewart, Offutt Air Force Base, reported that Col. Dayton could not be here today because he was called to assist with hurricane activity in Florida. Lt. Col. Stewart himself is new to the State of Nebraska and this past summer and he and his wife were impressed with the smooth transition of enrolling their children in an area Nebraska school.

Commissioner Blomstedt stated that in the 5 ½ years he has been Commissioner, he has not been aware of any problems with transitioning military children into schools in the State of Nebraska. He commended the area schools in their efforts to make the transition as effortless as possible for military families.

Brian Halstead, Compact Commissioner, stated that he is beginning his 4th year of serving as Compact Commissioner and no issues have arisen in the past year, and only one instance has occurred during his service as Compact Commissioner that was satisfactorily resolved at the school level.

Sara Hulac stated that this past year she is not aware of any issues.

Nicole Barrett, Policy Research Analyst, indicated that Senator Mike Groene's office did not receive any indication of issues pertaining to the Compact this past year.

Brian Halstead indicated that he has a schedule conflict and cannot attend the 2019 Annual Business meeting in Colorado Springs, CO October 22-24, 2019. Compact Commission bylaws indicate that an official Delegation of Authority to another person should be made for another individual to attend on his behalf. Mr. Halstead recommends Scott Summers, NDE General Counsel.

State Department of Education/Public Instruction COVID-19 Information/Guidance on School Closures and Reopening

As states reopen, reassessing the impact of COVID-19 while maintaining community safety and health is paramount. While most state departments of education and public instruction have published reopening frameworks, it's still too early to determine which options will be selected at this time, as plans change weekly based on the number of COVID-19 cases within a state. When and how a district will reopen vary and are largely determined by local district, board of education and health authorities.

At end May, the Centers for Disease Control and Prevention (CDC) released reopening guidance for schools and daycares. In addition to state guidance, other considerations include: state and local public health mandates, state and community COVID-19 data, and implementing safety measures to protect students, families, and school personnel.

All 50 states and the District of Columbia have released guidance for districts on school reopening, several have released additional or updated guidance. As schools reopen, districts continue to adjust plans as state status' and COVID-19 data is updated.

Under continual discussion is the status of high sports and other extra-curricular activities, with several states delaying the fall sports season. For the [current list](#), visit the National Federation of State High School Associations (NFHS) website.

GUIDE FOR SCHOOLS/PARENTS



What is the Compact?

The Compact deals with the challenges of military children and their frequent relocations. It allows for uniform treatment as military children transfer between school districts in member states.

Note: The Compact only applies to public schools.

Students Covered

- Active duty members of the uniformed services, including members of the National Guard and Reserve on active duty orders (Title 10)
- Members or veterans who are medically discharged or retired for one year
- Members who die on active duty, for a period of one year after death
- Uniformed members of the Commissioned Corps of the National Oceanic and Atmospheric Administration (NOAA), and United States Public Health Services (USPHS)

Students Not Covered

- Inactive members of the National Guard and Reserves (Not Title 10)
- Members now retired not covered above
- Veterans not covered above
- Other Department of Defense personnel, federal agency civilians and contract employees not defined as active duty
- Members other than the uniformed personnel of NOAA and USPHS

May be required during transition

- Official military orders showing that the military member was assigned to the state (or commuting area) of the state in which the child was enrolled and attended school
- If a military child was residing with a legal guardian and not the military member during the previous enrollment they will have a copy of the family care plan, or proof of guardianship
- A transcript, official or unofficial, or an official letter from the proper school authority which shows record of attendance, academic information, and grade placement of the student
- Documented evidence of immunization against communicable disease.
- Evidence of date of birth.



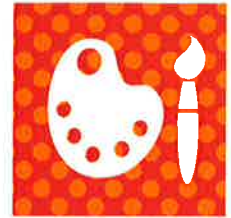

Graduation

- Waiving courses required for graduation if similar course work has been completed
- Flexibility in accepting state exit or end-of-course exams, national achievement tests, or alternative testing in lieu of testing requirements for graduation in the receiving state
- Allowing a student to receive a diploma from the sending school instead of the receiving school
