Bills Before the 107th Legislature

- LB5** (Senator Blood) - Adopt the Purple Star Schools Act - **Proponent at hearing; Education Committee**
- LB135** (Senator Wishart) - Change special education reimbursements - **Proponent at hearing; Education Committee**
- LB137** (Senator Vargas) - Require reporting to the Nebraska Early Childhood Professional Record System; **Proponent at hearing; Education Committee**
- LB322** (Senator Williams) - Adopt the School Safety and Security Reporting System Act - **Proponent at hearing; Education Committee**
- LB323** (Senator Walz) - Change provisions of the Tax Equity and Educational Opportunities Support Act relating to pandemics – **Proponent at hearing; Education Committee**
- LB359** (Senator Pansing Brooks) - Change provisions regarding multicultural education as prescribed and provide powers for the State Board of Education - **Proponent at hearing; Education Committee**
- LB396** (Senator Brandt) - Adopt the Nebraska Farm-to-School Program Act - **Proponent at hearing; Education Committee**
- LB428** (Health & Human Services Committee) - Entitlement of juveniles at youth rehabilitation and treatment centers to receive an appropriate educational equivalent to educational opportunities offered in public schools and maintain accreditation, similar to public school districts, at Youth Rehabilitation and Treatment Centers (YRTC) - **Proponent at hearing; DHHS Committee**
- LB527** (Senator Walz) - Change provisions relating to transition services for students with a developmental disability - **Proponent at hearing; Education Committee**
- LB528** (Senator Walz) - Change, eliminate, and add provisions relating to education - **Proponent at hearing; Education Committee**
- LB529** (Senator Walz) - Change provisions for the distribution of lottery funds used for education, transfer powers and duties, create new acts and funds, and change education provisions - **Proponent at hearing; Education Committee**
- LB538** (Senator Walz) - To adopt the Community Schools Act; **Proponent at hearing; Education Committee**
- LB565** (Senator McDonnell) - Requires the NDE develop and implement a youth initiated mentoring pilot program; **Proponent at hearing; Education Committee**
- LB568** (Senator Pansing Brooks) - Change provisions relating to truancy, juvenile courts, the Community-based Juvenile Services Aid Program, the Commission Grant Program, and compulsory education - **Proponent at hearing; Judiciary Committee**
- LB587** (Senator McDonnell) - Adopt the Career Mentoring Grant Act - **Proponent at hearing; Education Committee**
- LB642** (Senator Day) - Provide for reimbursements to school districts and educational service units for mental health expenditures **Proponent at hearing; Education Committee**
