## Title I Nonpublic Consultation Form

### SCOPE

The Title I Nonpublic Consultation Form provides a form for the Public district to use when consulting with Nonpublic systems regarding Title I, Part A participation. This Form is required for each approved or accredited Nonpublic school with resident low-income school aged children.

The Public school district is not required to complete or submit this Form for Rule 12 or Rule 13 exempt status schools in the public district.

### DIRECTIONS

#### Access

Accessing the Title I Nonpublic Consultation Form requires a Consolidated Data Collection (CDC) activation code – Federal, All or Approver UserType. If you do not have the Consolidated Data Collection (CDC) in Data Collections, you will need to obtain an activation code from your District Administrator.

**Process**

1. Download forms to be used in consultation with the Nonpublic system(s).
2. Public district representative consults with the Nonpublic system(s) representative(s).
3. After completion of the Nonpublic consultation itself, the Public district will enter data from the form into the Title I Nonpublic Consultation Form collection in the CDC.
4. Public District submits and approves by due date, and audit window period is allowed for corrections.
5. Public Districts keep the paper forms used in the consultation, with the original signatures, on file at the district for 6 years (for audit purposes).

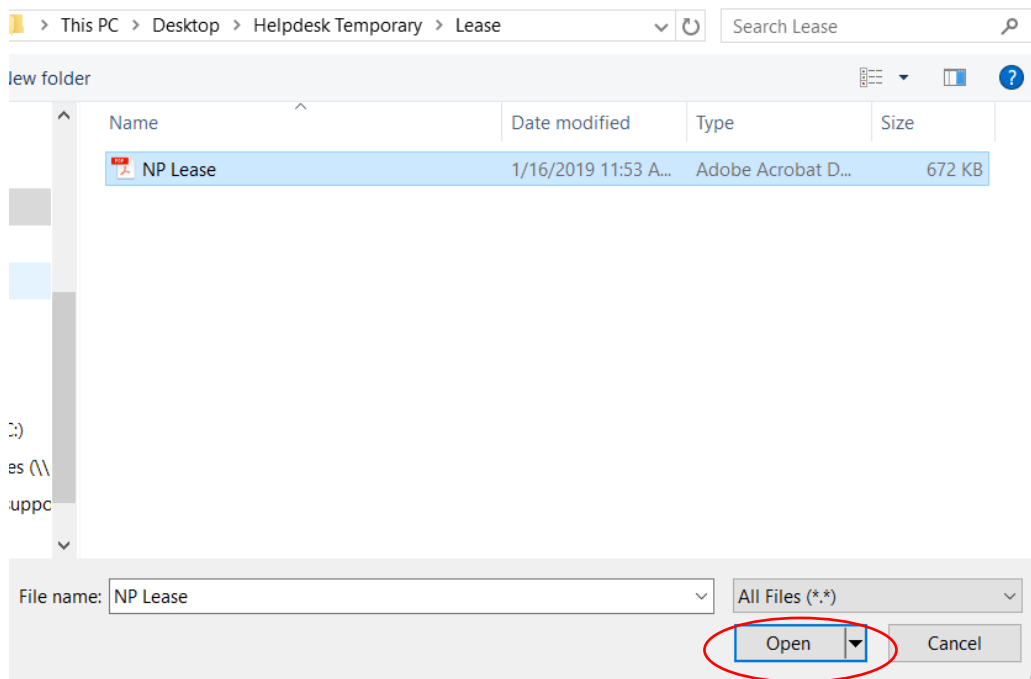
