

Nebraska Rule 24 Endorsements, Required *Praxis* Subject Assessment and School Leadership Series Content Tests, and Passing Scores

Effective September 1, 2015: All candidates applying for certification in Nebraska must provide evidence they have taken the required content test and received the required passing score to have the endorsement placed on a Nebraska teaching certificate or permit for the first time.
